

Choice Partners Contract Summary

Stylex has been awarded a direct contract with Harris County Department of Education (TX), and Choice Partners (CP) as a source of supply for Office Furniture and Related Items. This agreement is available for use by all schools, colleges, universities, cities, counties and other government entities in the United States.

Orders must reference the contract number 18/015KC-05. Orders must include appropriate product items with correct color choices, quantities, net prices, ship-to location, a point of contact, and servicing dealer. Orders must show the correct net prices, otherwise the order will be returned for modification.

Products

All Stylex products are approved annually and available on this contract. New products may be added, but must be submitted to Choice Partners by Stylex.

Freight Terms / Delivery

Freight terms for this contract are FOB Destination, meaning Stylex will pay freight to anywhere in the contiguous 48 States. Orders are to ship to one location. For multiple locations, prior approval is needed from Stylex, in order to receive contract discount. Standard lead-times shall apply. Customers may ask for expedited delivery, or delay of delivery. Stylex Customer Service shall be contacted to coordinate these requests on a case-by-case basis.

Services

Design services are available, quoted on a project-by-project basis. Installation services are available, quoted on a project-by-project basis, not to exceed \$100.00 per hour. This service may require union rates and labor.

Payments

Payment terms are Net 30 Days.

Stylex will accept government procurement cards for orders, at no additional discount. Credit card information must be made available at time of order entry, and appropriate signature is required.

Cancellations / Return Policy

Cancellation of orders prior to production shall be at no charge. After production, cost incurred may be applicable.

Returns will not be accepted without written authorization by Stylex. Agencies shall pay and bear responsibility for returns. Returns are subject to a restocking fee.

Warranty

Stylex standard warranty shall apply, please see warranty statement within the price list.

Administrative Fees

Stylex is responsible for a monthly sales report to Choice Partners, and a subsequent administration fee based upon invoiced sales.

Servicing Dealer Responsibilities

Servicing Dealers are responsible for assisting any government agencies with any and all contract orders. Dealers are NOT allowed to change any contract term or condition, including products available, discounts, net prices or delivery. Dealers shall promote the contract in a professional manner.

Dealers must familiarize themselves with the contract terms and conditions, and maintain appropriate insurance requirements. Dealers must also be in good standing with Stylex. Stylex is responsible for monthly sales reporting. The dealers may be called upon for reporting assistance.

Choice Partners

Choice Partners purchasing cooperative offers procurement and contract solutions to meet government purchasing requirements. As a division of a government agency and former school district, Choice Partners contracts are awarded by the HCDE governing board of trustees. Interlocal government-to-government agreements are between HCDE and the government entity wishing to use the Choice Partners cooperative contract.

Colleges and universities, counties, municipalities, school districts, and other governmental agencies and political subdivisions, and nonprofits within or outside Texas, may access Choice Partners National cooperative, legal, competitively bid contracts under Intergovernmental Code 791. Membership to Choice Partners is free.
